**URDHERARREST**

Urdherohet arrestimi i te pandehurve:

1. **ZVONKO VESELINOVIQ**, me nofken “Fiske”. nga i ati Jovan, i lindur me daten 30.12.1980, ne fshatin Dolane, komuna e Zveqanit, me vendbanim te perhershëm ne Mitrovica, rruga “Kral Petri” p.n., Serb, shtetas i Republikes se Kosoves, gjindet ne arrati.
2. **ZHARKO VESELINOVIQ**, nga i ati Jovan, i lindur me daten 23.02.1985, ne fshatin Dolane, komuna e Zveqanit, me vendbanim te perhershëm ne Mitrovica, rruga “Kral Petri” p.n., Serb, shtetas i Republikes se Kosoves, gjendet ne arrati.

Pas arrestimit te pandehurit te shoqerohen nga oficeri policor e te sillen te Gjyqtari i procedures paraprake ne Gjykatën e Qarkut, ne Mitrovica – lokalet e Gjykates Komunale, ne Vushtrri .

Urdherarrestin do ta ekzekutoje Njesiti per krime serioze, ne Mitrovica ne bashkëpunim me Stacionet tjera policore ne Kosove .

## Arsyetim

PPQ ne Mitrovice me kerkesen PP.nr.192/11 te dt. 22.12.2011,ka kerkuar leshuarjen e urdherarrestit ndaj te pandehurve Zvonko Veselinoviq dhe Zharko Veselinoviq, per shkak te dyshimit te bazuar se te njëjtit ne bashkëveprim kane kryer veprat penale : Rrezikim i personelit te Kombeve te Bashkuara dhe i personelit ne marrdhenje me to, nga neni 142 par 3 lidhur me par 2 te KPK e lidhur me nenin 23 te KPK, vepres penale Vrasje e rende , nga neni 147 pika 4 dhe 10 te KPK, lidhur me nenin 23 te KPK, vepres penale Mbajtje ne pronesi, kontroll, posedim ose ne shfrytëzim te paautorizuar te armeve nga neni 328 par 1 dhe 2 te KPK, vepres penale Pengim i personit zyrtar ne kryerjen e detyrave zyrtare, nga neni 316 par. 1 dhe 2 te KPK lidhur me nenin 23 te KPK, vepres penale Sulm ndaj personit zyrtare gjate kryerjes se detyrave zyrtare, nga neni 317 par. 3 te KPK lidhur me par. 1 e lidhur me nenin 23 te KPK, vepres penale Thirrja per rezistenc ,nga neni 319 te KPK, vepres penale Pjesmarrja ne grup qe kryen veper penale, nga neni 320 par. 1 dhe 2 te KPK e lidhur me nenin 23 te KPK, vepres penale Shkaktim i rrezikut te pergjithshem, nga neni 291 par. 5 lidhur me par. 1 te KPK e lidhur me nenin 23 te KPK, dhe vepres penale Kontrabandim i mallrave nga neni 273 par. 1 te KPK lidhur me nenin 23 te KPK . PPQ ne kerkes theksone se jane përpjekur permes policise te sigurojne pranin e te pandehurve ne seancen degjimore por nuk kane arritur ti sigurojn sepse te njëjtit gjinden ne arrati ne teritorin e Republikes se Serbise.Meqenëse te pandehurit e lartcekur nuk kane mund qe te sigurohen per seancen degjimore pasi qe gjinden ne arrati ne teritorin e Serbise e ku ftesat nuk mund te ju dorëzohen ne menyrt te rregullt pasi qe gjinden ne adresa te panjohura e ushtrojn ket terkes per lshuarjen e urdherarrestit nga ana e Gjykates.

Dyshimi i bazuar se te pandehurit kane kryer veprat penale qe ju vehen me barre nga ana e PPQ, bazohet nga aktvendimi mbi fillimin e hetimeve , shkresave te policis si dhe fakti se te pandehurit pase kryerjes se veprave penale te lartcekuar jane arratis dhe te njëjtit policija edhe pse jane përpjekur ti arrestojn por pa sukses dhe te njëjtit kane vereteue se nuk gjinden ne shtepit e tyre por jane arratisur ne Serbi. ne adresa te panjohura.

Meqenese ne kete menyre munde te sigurohet prezenca e tyre ne kete gjykate eshte opurtune qe te leshohet urdherarresti.

Nga sa u tha me larte jane plotsuar bazat ligjore te parapara me nenin 270 par.1 te KPPK per leshuarjen e urdherarrestit.

**PRE TRIAL JUDGE in District Court in Mitrovica** , Ferit Osmani in the criminal case against the suspect Zvonko Veselinoviq and Zharko Veselinoviq from Mitrovica , because of the based suspicion that the same in interaction committed criminal offences: Endangering United Nations and associated personnel from article 142 paragraph 3 related to paragraph 2 of PCCK related to article 23 of PCCK, criminal offence Aggravated murder from article 147 item 4 and 10 of PCCK related to article 23 of PCCK , criminal offence Unauthorized, control, possession or use of weapons from article 328 paragraph 1 and 2 of PCCK, criminal offence Obstruction of the official person in performing official duty article 316 paragraph 1 and 2 of PCCK related to article 23 of PCCK, criminal offence attacking official person in performing official duty article 317 paragraph 3 of PCCK related to paragraph 1 and related to article 23 of PCCK, criminal offence Call to resistance article 319, criminal offence participating in a crowd committing a criminal offence article 320 paragraph 1 and 2 of PCCK related to article 23 of PCCK , criminal offence Causing general danger article 291 paragraph 5 related to paragraph 1 of PCCK related to article 23 of PCCK and criminal offence Smuggling of goods article 273 paragraph 1 of PCCK related to article 23 of PCCK while deciding based on the Mitrovica DPP request PP No 192/11 dated on 22.12.2011 , for issuing of the arrest warrant , conform article 270 of PCCK dated on 22.12.2011 issued this:

**ARREST WARRANT**

It is ordered arrest of the defendants

1. **ZVONKO VESELINOVIQ**, with nickname “ Fiske” father’s name Jovan, born on 30.12.1980 in Dolane village, Zveqan Municipality with permanent residence in Mitrovica, street: “ Kral Petri” N/N , Kosovar /Serbian , at large
2. **ZHARKO VESELINOVIQ**, father’s name Jovan, born on 23.02.1985, in Dolane village , Zveqan Municipality with permanent residence in Mitrovica, street: “ Kral Petri” N/N Kosovar, Serbian , at large.

After the arrest the defendants to be accompanied by Police Officer and to bring them to the District Pre Trial Judge in Mitrovica- offices of the Municipality Court in Vushtrri.

The arrest warrant will be executed by Serious Crime Unit in Mitrovica in cooperation with the other Police Stations in Kosova.

## REASONING

DPP in Mitrovica with the request PP No 192/11 dated on 22.12.2011 requested issuance of the arrest warrant against the defendants Zvonko Veselinović and Zharko Veselinović because of the based suspicion that the same in interaction committed criminal offences : Endangering United Nations and associated personnel from article 142 paragraph 3 related to paragraph 2 of PCCK related to article 23 of PCCK, criminal offence Aggravated murder from article 147 item 4 and 10 of PCCK related to article 23 of PCCK , criminal offence Unauthorized, control, possession or use of weapons from article 328 paragraph 1 and 2 of PCCK, criminal offence Obstruction of the official person while performing official duty article 316 paragraph 1 and 2 of PCCK related to article 23 of PCCK, criminal offence attacking official person in performing official duty article 317 paragraph 3 of PCCK related to paragraph 1 and related to article 23 of PCCK, criminal offence Call to resistance article 319, criminal offence participating in a crowd committing a criminal offence article 320 paragraph 1 and 2 of PCCK related to article 23 of PCCK , criminal offence Causing general danger article 291 paragraph 5 related to paragraph 1 of PCCK related to article 23 of PCCK and criminal offence Smuggling of goods article 273 paragraph 1 of PCCK related to article 23 of PCCK. DPP request emphasize that they have tried through Police to provide the presence of the defendants in the hearing session but they could not provide them since they are at large ( runaway) in territory of Serbia where the summons can not be handed in proper way since they are in unknown addresses while submitting this request for issuing the arrest warrant from the Court.

Based suspicion that the defendants committed criminal offences that they were charged with by DPP, it is based on the decision for initiating the investigations, Police documents and the fact that the defendant after committing the above mentioned criminal offences escaped and the same ones even that Police tried to arrest them but unsuccessfully and the same ones confirmed that they were not in their houses but they escaped (at large) in Serbia, to unknown addresses.

Since in this way could be ensured their presence in this Court it is opportune ( appropriate) to issue the arrest warrant.

As what was said above the legal grounds were fulfilled which are foreseen based on the article 270 paragraph 1 of PCCK for issuing the arrest warrant.
